NRC is in Syria to support people affected by forced displacement (IDPs, returnees, host community etc.) so that they can have access to timely and effective assistance, to cope with the crisis and when the crisis ends return and rebuild their lives. Since the start of its activities in mid-2016 in Syria, NRC has reached with humanitarian assistance more than 360,000 people, out of which more than 150,000 reached in 2018 alone in the Governorates of Damascus, Aleppo and Rif Damascus.

NRC will continue to apply an integrated programming approach, where Education, capacity building, Shelter/WASH, and Food Security and Livelihoods (FSL) programmes work jointly to enable displacement-affected populations to meet their basic needs, enjoy their rights, and benefit from pathways to durable solutions.

### **Background**

The Logistic officer is a member of the Logistics team in the Area office. The Logistic department is responsible for logistical processes including procurement, warehouse, asset and fleet management of the organization in a highly challenging and volatile context.

The purpose of this position is to provide the day to day implementation of the procurement function's responsibility.

# **Role Specific Information**

- Directly responsible of all assigned procurement processes up to the defined threshold and at the discretion of Logistics Coordinator. Actively, engage on national tendering process (exceeding the defined threshold).
- Ensure all procurement under his/her responsibility are processed as per priorities, NRC and Donors' standards, requirements, and in a timely manner.
- Under guidance of Logistics Coordinator; to support the prequalification of suppliers, markets surveys, price lists, vendor databases.
- Advise and support NRC Syria programme staff in the field in all procurement processes.
- At the discretion of the Logistics Coordinator, contribute to assessments/reports of existing logistical operations and advise on corrective measures to be undertaken.
- Liaise and coordinate with the relevant parties regarding delivery of supplies and keep them informed of any changes in a timely
- Ensure that procurement reports are prepared and submitted on time to relevant stakeholders.
- Prepare and develop procurement reports as required by Country Office.
- Liaison and collaborate with relevant local authorities and/or stakeholders.
- Establish and maintain good professional working relationships with suppliers, service providers and contractors whilst strictly
  adhering to NRC's anti-corruption guidelines and NRC's code of conduct.
