## JOB VACANCY - Mental Health Supervisor (Swaida)

*Médecins Sans Frontières* (MSF) is an international, humanitarian, non-governmental organisation providing assistance to people in need as a result of natural and man-made disasters, irrespective of race, religion, ideology or politics.

MSF is currently seeking to employ a qualified candidate for the following position with a contract until 31/01/2026.

Position: Mental Health Supervisor

Location: Swaida /Syria

#### Scope of responsibilities:

Participate in the planning, supervision and coordination of mental health / pycho-social related services in the program in accordance with MSF standards to provide the most appropriate mental health support for patients.

#### Main tasks:

- Participate in the planning, organization and coordination of Mental Health activities, in close collaboration with
  the Mental Health activity manager and other medical team members, in order to ensure an efficient and effective
  implementation of the resources needed while maintaining high levels of quality in Mental Health MSF programs
  and activities.
- Coordinates activities of counseling services with other relevant actors and liaises with the local counterparts (like MoH, WHO, ICRC and NGO) on mental health matters, including referral services.
- Supervise the daily mental health activities and patient support according to MSF protocols and standards in order to provide the most appropriate support for clients with psychosocial needs
- Liaise with the other MSF team members of the project.
- Supervise, in close coordination with the HR department, the associated processes (recruitment, training/induction, evaluation, potential detection, development and communication) of the staff under his/her responsibility in order to ensure both the sizing and the amount of knowledge required
- Oversee the administrative processes associated with psychosocial functioning.
- When needed, give psychological support to patients according to MSF protocols to improve mental health conditions of patients and enhance their functionality.
- Compile the data and statistic linked with MH activities and report to the MH activity manager
- Offer clinical counselling supervision to mental health counsellors in collaboration with the Mental Health Activity Manager.
- Ensure the patient's related information is kept confidential

#### Additional context specific tasks:

- In close collaboration with other medical team members, identifying the needs of MH support in the target population and participating in the definition, planning, organization and update of the appropriate MSF strategy and the Mental Health (MH) activities and its budget.
- With the support of MH manager/advisor, build the capacity of DoH psychologists/counsellors by targeted training and supervision.
- Coordinate MH activities across fixed and mobile services, ensuring regular follow-up and appropriate referrals.
- Conduct trainings for counsellors, psychologists and healthcare workers on MH protocols, methods and standards and on PFA if not done.
- Ensure implementation of MH protocols and standards.
- Train the team on group and individual MHPSS sessions and follow up of the sessions.
- Participate in data collection and reporting.
- Participating in the MCI plan in the hospital and train hospital staff on PFA.
- Mapping and regularly updating the existing Mental Health services, including other INGO's, local NGO's, community groups and governmental health services, etc. and maintaining good and regular communication and collaboration with other components of the project according to objectives and context.
- Ensure appropriate management and referral of psychiatric cases requiring medication and specialized care.
