#### **1. Job Summary:**

The nurse will strive to contribute to an improvement in the overall health of the targeted population through the provision of quality health care (curative and preventive health care). The incumbent is expected to triage patients, ensure patient flow, provide clinical care, assist with referrals as required, and provide health education and hygiene promotion. In addition, the nurse may also be asked to assist health care staff in another capacity, as needed.

To carry out this work, a person must be able to perform each essential function with or without reasonable accommodations.

#### **2. Scope of Work**

The Nurse will be responsible for the following activities:

- To provide clinical nursing services according to internationally recognized standards.
- Assist clinicians, midwives, laboratory, immunization services and pharmacy in the performance of general duties designated by the supervisor.
- Manage triage, take vital signs, and organize patients for consultation.
- Vaccinate children and pregnant women.
- Make dressings, sutures for deep wounds, etc.
- Conduct patient nursing care in accordance with the physician's guidelines or instructions if he/she works in an inpatient department and perform duties in accordance with protocols.
- Ensure compliance with Ministry of Health and WHO guidelines on the rational use of medicines.
- In collaboration with the supervisor, provide treatment in accordance with Ministry of Health/WHO treatment guidelines and protocols.
- Ensure patients are enrolled and registered accurately for reporting and case management.
- Ensure proper data management by completing appropriate patient cards, logs, scorecards and reports.
- Support the conduct of laboratory and other tests that are available and accessible to patients.
- Provide health education and hygiene promotion to patients based on their diagnoses and comorbidities, including diet, activity, hygiene, and disease prevention (e.g., need to be vaccinated, suggest lifestyle changes, etc.).
- Attend the physical examination of sexual and reproductive health patients, especially for a male health care provider, whenever requested.
- Ensure that affected patients, including children under 5 years of age, are screened for malnutrition or provide malnutrition services, provided they are qualified and have been assigned responsibilities by the supervisor.
- Work with the supervisor to provide didactic and on-the-job training to build capacity and improve the skills of other staff such as CHWs and Licensed Practical Nurses.
- Collaborate with other departments, as required, to ensure smooth implementation and integration of services.
- Adhere to administrative guidelines regarding work schedules, record keeping, patient communication, confidentiality, restocking of essential medications, consumables, and other medical supplies.
- Perform additional duties as assigned, including triage, IPC, focal point for child protection, data distribution and/or management, as required.
- Assist with the installation, maintenance and mobilization of clinical spaces, as required.

- The duties and responsibilities listed are representative of the nature and volume of work assigned and are not necessarily exhaustive. The urgency of IMC's work requires staff to adapt to a rapidly changing landscape; Tasks can be reconfigured to meet operational requirements.

#### **Adherence to the policy**

- Actively promote PSEA (Prevention of Sexual Exploitation and Abuse) standards within the International Medical Corps and among the beneficiaries of its services.
- Adhere to the Code of Conduct, uphold humanitarian principles and respect international humanitarian law, at all times.

Perform other duties as assigned. The duties and responsibilities listed in this document are representative of the nature and volume of the work assigned and are not necessarily exhaustive.

### **3. MINIMUM QUALIFICATIONS**

- Qualified and registered nurse from a government-recognized nursing institute, with a valid licensure or similar qualification required in the country for the position.
- Previous experience in the same position will be an asset.
- Previous experience in an NGO is preferred.
- Good communication skills, both oral and written.
- Extremely flexible and able to deal with situations of stress and frustration.
- Ability to communicate with and motivate staff effectively.
- Good decision-making skills.
- Must work independently under difficult conditions.
- Able to take on non-medical responsibilities, from time to time, to replace other team members.
- Good reading and writing skills in English.
- Fluency in national and local languages orally.
