1. JOB SUMMARY

Nutrition nurse (IYCF) Facilitator will implement quality health and nutrition activities at the targeted sites. The nutrition nurse will work with field and office staff to ensure that the adequate and quality management of malnutrition cases among children from 6 to 59 months and pregnant and lactating women, in respect to the guidelines and Donor standards. To perform this job successfully, an individual must be able to perform each essential function with or without reasonable accommodation.

2. Scope of Work

The Nutrition nurse (IYCF) Facilitator will be responsible for the following activities:

- Adhere to UNICEF, WHO, WFP, and MoH guidelines on malnutrition.
- Screening of malnutrition for children from 6 to 59 months and pregnant and lactating women visiting International Medical Corps facilities.
- Identify malnutrition cases among screened beneficiaries.
- Work in close coordination with the field doctor to assure proper management and treatment of cases according to CMAM protocols and guidelines.
- Refer and follow up of sever cases of malnutrition.
- Perform needed health education counselling for beneficiaries.
- Ensure proper, clear and accurate data recording on clinical registration book and nutrition cards.
- Ensure that all program materials are well maintained.
- Propose solution to solve any problem faced and report them to related office staff.
- Develops and encourages new and innovative solutions.
- Prepare monthly nutrition reports.
- Perform any other requested tasks by direct supervisor or other supervisors in office.
- Comply with all relevant International Medical Corps policies and procedures with respect to child safeguarding policy, health and safety, equal opportunities and other relevant policies.

Perform other duties as assigned. The duties and responsibilities listed in this document are representative of the nature and level of work assigned and not necessarily all inclusive.

3. MINIMUM QUALIFICATIONS

- Working experience of two years in nutrition programs.
- Medical background (nurse, pharmacist, pharmacist assistant, or any related medical degree).
- Certificates in IYCF and CMAM programs is preferable.
- Good relations with other people.
- Good capacity to work in a team and flexibility.

- Good interpersonal and communication skills
- Good writing and presentation skills
- English fluency is preferable.
