

NRC in Syria

NRC is in Syria to support people affected by forced displacement (IDPs, returnees, host community etc.) so that they can have access to timely and effective assistance, to cope with the crisis and when the crisis ends return and rebuild their lives. Since the start of its activities in mid-2016 in Syria, NRC has reached with humanitarian assistance more than 360,000 people, out of which more than 150,000 reached in 2018 alone in the Governorates of Damascus, Aleppo and Rif Damascus.

NRC will continue to apply an integrated programming approach, where Education, capacity building, Shelter/WASH, and Food Security and Livelihoods (FSL) programmes work jointly to enable displacement-affected populations to meet their basic needs, enjoy their rights, and benefit from pathways to durable solutions.

Project M&E. Responsible for supporting the M&E Unit in achieving accurate and high quality Monitoring and Evaluation activities in accordance with the Syria Response M&E Strategy, tools and guidelines. This includes:
Collect construction/process outputs and outcomes.
Collect beneficiaries' feedback over implemented works.
Assess the quality of implemented works.
Any other relevant task.
- **Protection Mainstreaming.** Responsible for supporting the Protection Unit in protection mainstreaming in all Shelter/NFI/WASH activities throughout the project-cycle. All project activities will be conducted in accordance with the Protection Mainstreaming Strategy, tools and guidelines This includes:
Ensure safety and dignity of beneficiaries,
Understand their diverse needs,
Enable meaningful access to NRC's services,
Ensure adequate accountability to affected populations,
Ensure adequate participation and consultation,
Support the realization of their human rights.
- **Collaboration.** The position-holder is responsible for maintaining a collaborative working environment with other team members; Shelter/NFI/WASH project team, other Core Competencies team in addition to the Support Teams
