Ensuring the proper functioning and coordination of the mental health activity (Mental health, Patient Support, etc.) in Syria and providing support to the Project Activity Managers in order to ensure the delivery of quality medical care for patients and their communities and to improve the health condition of the population

### **ACCOUNTABILITIES**

- Support in following Mental Health related activities in Syria with the support of the Medical Coordinator and technical referents
- Participate in the day-to-day follow-up of Mental Health activities; Burn Care, MSF activity and Primary Health Care (PHC) centers
- Participate in the discussions of Mental Health strategy in Syria
- Ensures the MSF protocols and standard operating procedures implementation in all projects
- Define Mental Health staff training needs and the MH framework in collaboration with Project Activity Manager/MH Supervisor, Medical Coordinator and Mental Health regional advisor
- Ensure quality data collection and implementation of Mental Health Chronic Disease Care database in Syria
- Provide technical feedback and follow-up on the evaluation of psychiatrists and other Mental Health staff across MSF France program
- Conduct regular capacity building according to needs
- Participate in a Mental Health Technical Working Group meeting
- Support in the assessment of mental health needs and actors Mapping in Syria

- Facilitate the participation of the team in meetings as suggested by the MH Regional Advisor
- Conduct field visits based on project needs, addressing all Mental Health activities in Syria
